WHEREAS, the Douglas County Planning, Zoning, and Land Information offices have a plan for emergency calling, and


WHEREAS, the numbers and road names in Douglas County must conform to this plan,


BE IT FURTHER RESOLVED, that houses located on this road shall accept and use numbers as assigned by Douglas County.


